



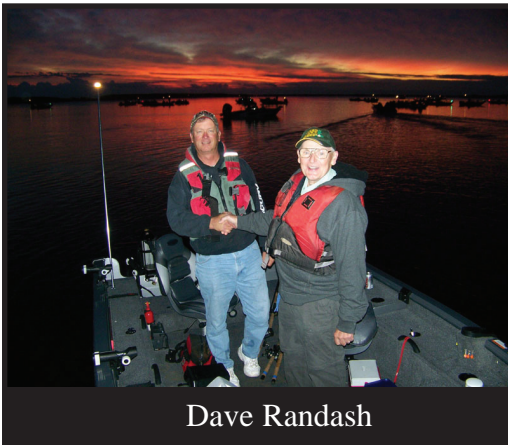

2010 LAKE WINNIPEG ICE FISHING EXCURSION

March 26th through 28th brought 65 members of FM Walleyes Unlimited to Selkirk, Manitoba for the 2010 Lake Winnipeg Ice Fishing Excursion to pursue trophy greenback walleyes on Lake Winnipeg. The group included several members who have made the trip in years past as well as a large number of "first timers" and included quite a few youth members of the club.

The event was kicked off Friday evening with an angler's social held at the Selkirk Inn & Conference Center. The social allowed members of FM Walleyes to meet and get to know members of the host club, the Walleye Anglers Association of Manitoba (WAAM). A total of 84 members of FM Walleyes and WAAM attended the social.

The evening included a short fishing seminar by local walleye guru Roger Stearns and instructions for the following morning. A raffle was held with prizes donated by Scheels, Northland Tackle, Live Target, Gate City Bank, Craig Stapon fishing rods and FM Walleyes. Two special raffles were held at the end of the night. Each club donated an entry to a regional tournament later in the year to be won by a member of the other club who was at the social. WAAM donated an entry into the Winnipeg River Greenback Championship in Pine Falls, Manitoba, which was won by Danum Hofland of Fargo. FM Walleyes donated an entry into the Cormorant Classic Tournament, which was won by Brian Seewald of Winnipeg.

Due to the warm spring weather and questionable ice conditions, many who attended brought ATV's and trailers. Others drove their vehicles out onto the ice. At 6:30 a.m. Saturday morning approximately 90 people made a convoy for a little over a mile out onto Lake Winnipeg to the predetermined fishing spot. The wind was howling, but the fishing was good. In an area of approximately 11 acres there were over 1,000 walleyes caught. Many people found success using Live Target Golden Shiner lures by Kopper's. These open water lipless crankbaits made for bass fishing proved deadly against walleyes feeding heavily on shiners and small tullibeas. The lures were jigged, twitched and snapped to create the action of a wounded baitfish. The walleyes were eating the lures, with most being caught with both treble hooks in their mouth. As the winds died down in the afternoon and the sun came out, many members of the group enjoyed grilled food and fresh fried fish.

Saturday evening was capped off by another angler's social back at the Selkirk Inn & Conference Center. The event included more socializing, sharing fish stories and the awarding of the big fish trophies. The largest walleye caught by a member of the WAAM club won a custom ice fishing rod donated by FM Walleyes club member Chuck DeRemer. This was won by Treavor Williamson, who caught a 28 3/4" walleye. The largest walleye caught by a member of FM Walleyes won a hand carved walleye donated by Eric Meder, a member of WAAM. Steve Meyer won this award with a 28" walleye. Steve dedicated the carving as a traveling trophy to be passed on each year to the angler catching the largest walleye on Saturday of the Lake Winnipeg Ice Fishing Excursion.



Most who were in attendance would agree that the trip was a success. There were eleven master angler qualifying fish caught by FM Walleyes members. To qualify for this distinction the fish were 28" or longer. There were countless fish caught in the 20 to 25" range and many 26 & 27"ers as well. Many who were there caught the largest walleye of their lives. Everyone caught memories that will last a life time, or at least until the 2011 Lake Winnipeg Ice Fishing Excursion!

MARCH MEETING RECAP

Angler's Night 2010 brought a crowd of well over 100 to the Kelly Inn during the midst of the Red River flood to hear Chase Parsons share his knowledge of walleye fishing. Chase, son of Gary Parsons and nephew of Keith Kavajecz, has earned the respect of the walleye fishing world during his relatively young career. With a presentation that included pictures and video clips from "The Next Bite" television program Chase explained some of the finer points of live bait rigging, jigging in current and pulling crankbaits for walleyes.

Chase spent a good amount of time explaining the "slow death" technique. This approach to fishing crawlers involves threading a half crawler onto a "slow death" hook creating a bait that spins in a corkscrew fashion. This motion replicates the action of a dying minnow. Chase emphasized that this is not a "fish finding" method, but rather a way to entice fish to bite in an area where they are congregated. This is due primarily to the fact that the action is best at 0.7 to 1.3 m.p.h.. Chase does not use any spinners or beads with the "slow death" technique as it tends to inhibit the action of the bait. He mentioned that since the hooks are covered up, hook color does not matter. A 1.5' to 8' leader is used depending the surrounding conditions; longer leaders in clear water and shorter when snags are prevalent.

Jigging for walleyes is one of Chase's favorite techniques. He feels confident that with today's plastic baits, live bait isn't necessary. Chase explained that the techniques of rigging and jigging are two presentations where spending extra money on a rod is worth it. He recommends a short rod for jigging, 6'0" to 6'6" with a fast action paired with a small reel. Chase also recommended tying fireline directly to the jig rather than using a monofilament leader. Using a second plastic tail on a jig in dark or dirty water can help the walleyes find the bait easier, increasing your odds of catching more fish.

The last area that Chase discussed was the use of crankbaits for catching walleyes. When the water temp is below 50 degrees he recommends subtle stickbaits with more roll and less wobble. Between 50 and 70 degrees he would use moderate action small divers with both roll and wobble. Finally, once the water reaches temperatures above 70 degrees he would use large divers with lots of roll and wobble. His recommendation was use shad style baits in forage colors in when the water is clear, bright colors in stained water. Chase's favorite colors include pearl/white and chartreuse/pearl. Chase would recommend using monofilament line whenever possible as the stretch that it provides is valuable in landing big fish. When extra depth is needed or there is a large amount of debris in the water, fireline may be a better option.

Chase wrapped up his seminar with a question/answer session, providing additional information for those who were there.

ZEBRA MUSSELS UPDATE

Due to the finding of zebra mussels in the Pelican Lakes Area in September 2009, the following water bodies are designated as being infested with zebra mussels:

Big Pelican Lake (56-0786), Little Pelican Lake (56-0761), Bass Lake (56-0770), Fish Lake (56-0768), Lake Lizzie (56-0760), Crystal Lake (56-0749), Prairie Lake (56-0915), and the Pelican River from the outlet of Fish Lake downstream to Prairie Lake.

With this designation, certain laws now exist on these waters. One of these is that personal harvest of bait is not allowed on these bodies of water. Bait dealers may still harvest in these waters if they have a commercial bait dealer license, applied for a permit from the DNR, and also undergone a training for working in the infested waters. So yes, it is true that minnow seining is not allowed on the above waters unless the person is a commercial bait dealer with a permit from the DNR. However, because Big Cormorant is not designated as being infested with zebra mussels, minnow seining for personal use is still allowed. BOARD MEETING MINUTES – Tuesday, March 16, 2010 @ Doublewood Inn, Fargo ND

-Meeting was called to order @ 7:00pm by President, Gary Sauvageau.

Absent Board Members: Ed Liberda, Brian Dahlin.

General Members Attending: Ron Sahr & Scott Stillwell

-Review of last month's board meeting minutes & annual meeting minutes. Motion to approve both was made by Steve Garten, second by Steve Hall. All in favor, motion passed.

-Treasurer's Report, Barry Chouinard. Current balance: \$7,808.66. Barry gave overview of expenditures & deposits. Motion to approve balance was made by Steve Meyer, second by Kyle Agre. All in favor, motion carried

-Current Membership: 254 paid members (74 pending renewal).

-Last month's meeting attendance: 110.

OLD BUSINESS:

-Winnipeg Ice Fishing Event, Kyle Agre. Event is scheduled for the last weekend in March @ Selkirk. Currently @ 48 members confirmed with possibility of 65 at this point. Kyle mentioned that we are looking for 4 blow horns to use for the trip for each group to have & wondered if anyone had any that the club could use. Steve Meyer made a motion for the club to purchase 4 blow horns for use at the ice fishing event & other club events. 2nd was made by Scott Brewer, all in favor. Motion carried.

-Winnipeg Trip Donations, Scott Brewer. Scott talked about the donation of \$120 valued club hats to be used as door prizes at the social to be held on Saturday night of the ice fishing event. Steve Meyer moved to approve the hat donation for the event. 2nd made by Kyle Agre. All in favor. Motion passed.

-Donation Requests, Steve Garten. (1) 2 MN DNR Requests: 1st The Detroit Lakes Fisheries Office for \$3980 for rearing pond leases around White Earth lakes area. Annually the club has donated the percentage of the request that represents waters that are not netted. This year the club would pay \$2,426 (61% of the total requested). 2nd The Fergus Falls area requested a donation of \$800 to cover the 4 pond leases that they handle. Steve Meyer made a motion to approve both the DNR requests as stated. Steve Hall seconded motion. All in favor, motion carried. (2) Friends of Lake Sakakawea have requested that we renew our Silver Business Membership. Motion made by Barry Chouinard to renew membership. 2nd by Scott Brewer, all in favor. Motion passed. (3) Northern Lights Council Boy Scouts requested \$1500 donation to operate & maintain 18 boat motors throughout their 2010 boy scout program. This request had been tabled last month. Discussion continued. Scott Brewer made motion to ask Northern Lights to provide further information regarding this request before making final decision on this year's request. 2nd by Steve Hall. Vote was 6 in favor with 2 against, motion carried. (4) River Keepers requested assistance with their annual event to be held on Monday, June 7th, 2010. Steve Hall has been assisting with this event for the past years & has again offered to volunteer. As far as the financial support, Steve Garten will send written request to them to further define the financial support that they are requesting.

The board discussed that we would give the chairman of the donation request committee (currently Steve Garten) the power to deny donation requests that do not meet with the clubs set criteria. Motion made by Barry Chouinard, 2nd by Scott Brewer. All in favor, motion passed.
