DNR REGULATIONS

Minnesota lawmakers urging DNR to craft new invasive-species rules soon. DNR feeling pressure to formulate stricter regulations

State lawmakers are urging the Minnesota Department of Natural Resources to move faster in crafting new laws to stop the spread of zebra mussels and other aquatic invasive species. Rep. Dennis McNamara, R-Hastings, told DNR officials last week during a House hearing that the Legislature is ready to hear proposals as soon as possible. "You can't sit on your hands and not deal with this," said McNamara, the chairman of the House Energy, Environment and Natural Resources Policy and Finance Committee. "I want legislation here shortly to deal with this in a major way."

DNR officials told McNamara's committee some far-reaching proposals could infringe on boaters' movement from lake to lake and would be expensive. They also said fighting the pests would require help from local governments. "We get a lot of, 'The DNR is not doing enough,' " Luke Skinner, DNR invasive species program supervisor, told the House committee. "But we turn around and say, 'Help us.' " McNamara's challenge was a clear signal to the DNR to formulate the most stringent rules yet to prevent the spread of aquatic invasive species, especially zebra mussels.

Lake associations, county commissioners and homeowners are pressuring the DNR to slow the spread of invasive species now that zebra mussels infest Lake Mille Lacs, Lake Minnetonka and other high-use waters. DNR officials say they are working on legislation that would:

- Increase penalties for people who transport invasive species, making fines comparable to those for fish and wildlife violations. The move could raise such fines by several hundred dollars.
- Require special training and permits for companies that install docks and boatlifts. Such equipment can become a vector for invasive species, especially zebra mussels, and the DNR wants such workers to be trained to deal with invasive species.
- Hire more conservation officers. The agency has 22 open conservation officer positions out of more than 150 because of recent retirements.

DNR officials presented lawmakers with a list of suggested actions to stop the invasive species formulated by hundreds of lakeshore owners, associations, county commissioners and others who participated in public-input meetings and committees.

Skinner acknowledged the need for action with zebra mussels in Lake Mille Lacs.

"We think that aquatic invasive species are a serious threat to the state, and we are seeing an unprecedented movement of some of these species," he said. "It is a high priority for us."

Enforcement efforts are already resulting in more citations. Conservation officers wrote 57 civil citations in 2009, a number that jumped to 156 in 2010.

Despite having fewer officers, the DNR spent 12,800 hours enforcing invasive species laws in 2010, up from 4,800 in 2009. To double the number of hours spent on invasive species enforcement, the DNR would need \$1.6 million.

The DNR has discussed "containment zones" in which boaters would have to have their craft cleaned and inspected at decontamination stations. A major problem is Minnesota's vast number of lakes and lake accesses. Skinner said it would cost \$7 million to \$10 million to staff Lake Mille Lacs' 40 access points with staff 16 hours a day to inspect and clean boats.

"There is no way we can staff all 40 of the accesses and catch everybody coming off the lake," he said. New legislation should be prepared for the Legislature within a few weeks, and McNamara urged speed in crafting it. "We need to get serious and prepare for the upcoming boating season now," he said.

FM Walleyes Unlimited is donating over \$800 worth of children's books to Fargo Public Schools' elementary libraries. Members of the club will be delivering the books to the schools with the message: enjoy the outdoors and enjoy reading about the outdoors. The club purchased the books from FISH ON KIDS BOOKS™, chapter books targeted to second through sixth grade readers.

The series, authored by K.J. Houtman, starts with book #1, *A Whirlwind Opener*, set on the opening of fishing season in Minnesota. Book #2, *Driving Me Crazy* follows the main character, 11-year-old Gus Roberts, into camping on Memorial Day weekend at Itasca State Park and the headwaters of the Mississippi River. Book #3, *Spare the Rod*, kicks off summer vacation and a family trip to Wisconsin where more fun is in store than ATVing with his cousin, Colton. The books target fun adventures around fishing, camping and hunting—and Gus' most memorable moments are the surprises around every corner.

"Some of our members read the books themselves and approached the club that this was a perfect fit for the kids within our community," shared Kyle Agre, Youth Education Coordinator with FM Walleyes Unlimited. "Youth education and community outreach are top priorities for our club membership in respect to sharing our passion for the sport of fishing."

"These books will provide high interest, informational fiction-based stories for elementary readers. Students appreciate finding a book they enjoy reading and can relate to, and love when they find out it is written as a part of an on-going series," shared Rachael Agre, Director of Elementary Curriculum, Fargo Public Schools. FM Walleyes Unlimited also generously donated all three books in the series in audio format, which allows children of all reading levels access to the stories.

"It's a win-win," added author, K.J. Houtman, on hand at the recent FM Walleyes Unlimited event in Fargo. "The club has a chance to further their role of supporting kids and families with their outdoor sports, and the kids have a chance to read some fun and wholesome stories that embrace a lifestyle that is definitely a part of the culture in the Fargo-Moorhead area."

"We aren't done yet, either," added Barry Chouinard, FM Walleyes Unlimited club treasurer. "There are more schools and we'll order more books for donations around the Fargo-Moorhead area. It's great to have books that not only embrace the outdoor lifestyle in a positive light for kids, but also squeak in just a little instruction as well."

The books are adventure stories, but in the back of each book is a quick glimpse into Gus Robert's writing assignment at school: write about fishing to someone that doesn't know much about it. "That's where the kids will learn a little bit of 'how-to' information," added author, Houtman. "Although, my main goal in writing the books was to provide a fun adventure story that celebrates getting into outdoor sports."

RAFFLE WINNER

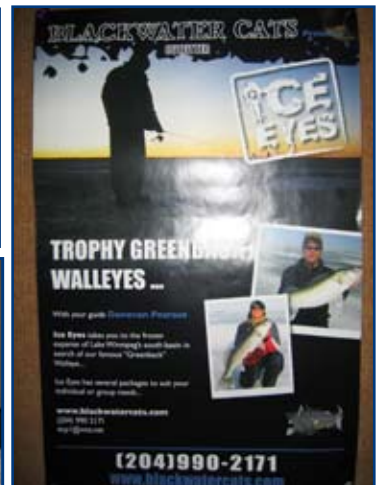
