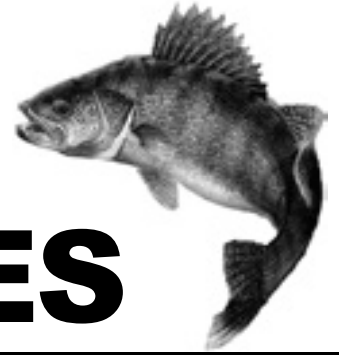

### Local Fishing Expert -- TJ BERGERON "Targeting Early Season Walleyes"

Our May speaker is a local native with a lifetime of expertise in fishing. TJ Bergeron grew up in Ottertail, MN. His father and grandfather were both fishing guides so it is no surprise that TJ landed his first walleye at the young age of 3. By the time Bergeron reached the age of 6 he had landed his first Musky measuring 39 inches. Eventually TJ followed the family tradition and became a 3rd generation guide. TJ was a member of the Lindy pro staff, has had articles published by In-Fisherman and Fins & Feathers.

Bergeron fished professionally for 7 years with numerous top 30 finishes in the MWC from 1986-1990. He was the youngest qualifier for the MWC National Walleye Championships in 86 & 87. Minnesota Governor, Rudy Perpich, named TJ Bergeron Minnesota's Best Fisherman in 1989. In 1990 TJ won the Pelican Lake Classic and the ND Governors Cup, took 3<sup>rd</sup> in the Montana Governors Cup and placed 4th at the South Dakota Governors Cup. 1990 was a pretty good year.

TJ loves to fish and he also loves to help people. TJ has over 20 years of sales experience in the fishing industry. TJ works for Sportsman's Warehouse where he can be found helping many club members in search of the perfect lure.

TJ's seminar – "Targeting Early Season Walleyes" – will focus on three areas: Location, Presentation and Equipment. Location topics will include where to look, what to look for, using maps and how does weather effect fish location. Presentation topics will cover what to use (jigs, rigs, cranks) and the effects of water temperature on making that decision. Lastly, TJ will discuss Equipment covering rods, reels, bait, line and electronics.



This should be a very informative seminar and I hope to see you all on Thursday, May 19th at the Doublewood Inn.  
*The doors open at 6:30 with the program starting at 7:00.  
Admission is free and open to the public.*

# Attention: Pelican Lake Tournament Participants

At the last F.M. Walleye Board of Directors Meeting it was decided that in an effort to increase participation and also to speed up the calcutta auction, we will be changing the calcutta format. Many of you have fished tournaments that use the format we plan to implement. A summary of this format follows:

- Each calcutta lot will consist of four (4) different fishing teams
- Calcutta lots are selected in the order of entry receipt
- Lot weight will consist of the total weights of the four fishing teams' two-day totals

An example follows:

*April Meeting Review by Jeremy Frie*

**STEVE HANSON OF SHIMANO**

Steve Hanson, representative of Shimano, AquaView, and Gamma Line, provided an educational presentation on Shimano products to the FM Walleyes audience. Shimano is a grass roots company, striving to pave the way for the industry. Their focus is gears. A good gear leads to the production of a good spinning reel. Shimano produces all of their own reel parts, either in Japan or Malaysia.

At the present time, reel manufacturers strive to re-invent the spinning reel. This is a difficult process as there are only so many things one can do to improve quality at this point. The buzz for the last few years has been the ball bearing count. Sure, more can be better if they are quality and located in the right part of the reel. More is not necessarily better, better is better. Shimano has developed the anti-rust bearing (ARB). This bearing has much more resistance to corrosion than standard types. They have increased the chromium content of the bearing, which provides more protection from rust. Shimano has also spent time in the area of the flippin switch and other parts of the reel to make them better. In the end, the consumer wins due to increased technology by all competitors.

Is a \$89 reel that much better than a \$29 one? Usually. Many of the reels priced less than \$49 have graphite frames. Those priced over \$49 usually have aluminum frames. Aluminum is more durable and usually results in a better product. As far as the consumer market, most spend between \$40-100 on a reel. Do you need to spend more than \$100 on a reel? Probably not unless you spend so many days on the water each year that you are wearing out the \$79 equipment! Spending between \$40-\$60 for a spinning reel will get you a quality product in most cases.

Electronics and computer chips...the wave of the future in fishing reels? Both are being added to high end models (\$400-\$500 range) today. Technology will continue to get better as competition grows with reel manufacturers. It's hard to picture a better reel than what is being produced today. Stay tuned. The next wave of technology might produce a better product than one could have ever imagined.

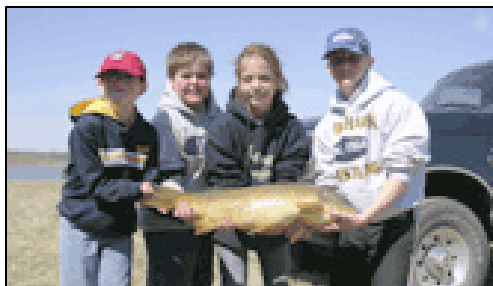

## ANNUAL MEETING UPDATE

Recently Steve Goldade and I attended the annual meeting of the North Dakota Sportfishing Congress in Bismarck.

The North Dakota Sportfishing Congress (NDSFC) is the umbrella organization for all the fishing clubs and anglers of North Dakota. It is designed to be a watchdog and work with the Game and Fish Department, North Dakota Legislature and the Congress of the United States. The NDSFC has an Executive Board consisting of a President, Past President, Vice-President, Secretary, Treasurer, and five Directors-at-Large. Each member club is allotted two voting delegates at each meeting. The NDSFC meets at least twice a year with the main annual meeting and election of officers in the spring. Executive Board meetings are held as needed.

This Organization has accomplished such things as construction of artificial fish habitat, cost share boat ramps and docks, family outings, rearing ponds, seminars, legislative forums, catch and release education, pathway programs, rough fish removal, and save our lakes projects.

Some facts that were discussed during the Annual Meeting:

- 1 Lake Sakakawea will reach a record low. The lake will drop another 7 feet in 2005.
- 2 The Corp would like to change how water is taken from the main lake. Mixing warmer water with the cold bottom water might save the cold water fishery and the smelt.
- 3 Devils Lake outlet is due to open on July 1<sup>st</sup>, 2005. It only has a 100 CFS flow. By permit the lake can only be lowered four feet. At the 100 CFS rate it will take 10 years to lower the lake 4 feet.
- 4 A huge stocking program is set for 2005  
200,000 Salmon • 40,000 Cutthroat • 20,000 Rainbow • 7,250,000 Walleye
- 5 We have lost approximately 80% of our smelt in the main lake
- 6 It was brought up that Senator Dorgan has been a huge supporter of the many projects concerning the fishing industry in North Dakota.
- 7 Ramps will be a challenge and many are currently being worked on.
- 8 Eighteen tournaments are scheduled for 2005 on Sakakawea. Many may be canceled with a four-week notice, depending on water levels. We have been assured the ND Governors Cup will not be cancelled.
- 9 Perch and crappie limits and a limit of one walleye over a set length were discussed.

I strongly encourage each and every one of our members to join this organization. Memberships are only \$5 per year, \$15 for 3 years or \$25 for 5 years. This is a family membership. 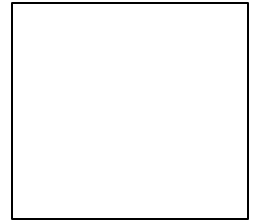
