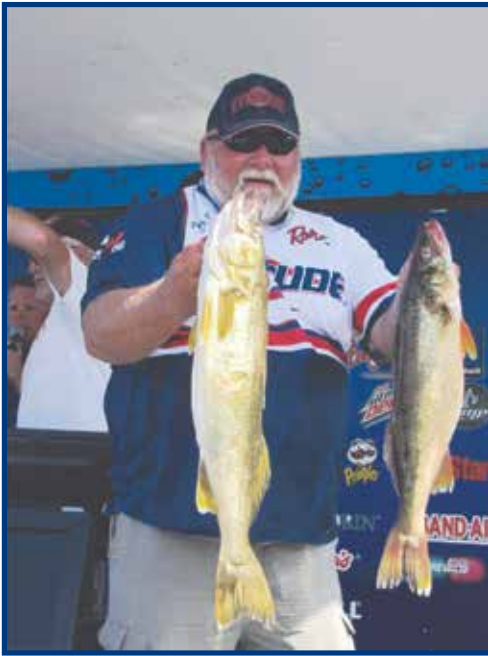

ASK THE PROS

with Corey Heiser and Troy Morris

APRIL'S QUESTIONS:

1. How often do you replace the line on your reels? What kind of of line do you prefer to use?

Troy Morris- *Monofilament: There are several great manufacturers of monofilament fishing line on the market today, Berkley Trilene and/or Northland Bionic are my favorites. There are 3 factors to take into consideration when deciding to replace your line, Friction (how many times do you let your line out and reel it back in), Snags (are you fishing snag infested waters stretching and breaking off) and Sunlight (how often you fish and do you leave your reels in the sunlight). These 3 factors can weaken even the best monofilaments and you will need to respool a couple times a year.*

Braided line: I have tried several braided lines and the one I would recommend using for multiple uses (trolling, casting, rigging) would be hands down Spiderwire Stealth Braid 15lb test – 4lb diameter. Berkley's Nanofil is a new line made specifically for spinning reels, it is tough, memory free, super thin and will drastically increase your casting distance, this is my choice of line when casting or pitching jigs.

Your line is the most vital link between you and your fish of a lifetime, respool before you think you need to, retie your knots often and use the correct knot for the line your using.

Corey Heiser- *It really depends on the line. Superlines, such as Spiderwire Stealth, Fireline or Powerpro, you can use them for multiple season without trouble. I will typically use for two seasons or more, depending on how much use and wear. It is easy to look at the line color and shape to determine. Mono needs to be changed more frequently. In fact, I will sometimes only use for a few days than change out, especially if I'm in snaggy conditions or casting applications. But at a minimum, mono is only good for one season. What kind of of line do you prefer to use? I try to use as many different lines as possible, depending on the situations. For trolling and pulling bottom bouncers, I use 15lb Spiderwire Stealth when I want a Superline and 10lb Berkley XT when using mono. For casting cranks and bobber fishing on Devils Lake, I use 15lb Spiderwire Stealth in hi-vis yellow. When rigging and jigging, I will use either XL or Sensation. Sensation in the hi-vis color really helps detect bites pitching jigs.*

2. Given the concerns with invasive species and the new laws implemented in Minnesota relating to bait, what do you recommend for bait management equipment and a bait management plan?

Corey Heiser- *My first plan is to use more artificials!!! I do have a cooler setup with an Oxygenator that I can transport minnows in my pick up. I make sure to fill with baitshop water and keep them from getting into infested waters. Since the rules have gotten more strict, I also buy less bait for each day that I fish eliminating waste of money and bait.*

Troy Morris- *Live bait is becoming a troublesome issue in the walleye fishing world. For several years I have been using more artificial baits than ever before, on most bodies of waters, and I have not had to worry much about a bait management plan. When I have dealt with bait issues when using red tails or chubs I have rented a slip and left my boat in the water over night. The best bait management system would be to start using as much artificial baits when you can, getting confidence is the biggest factor when using artificial, they do work most times better than live bait.*

3. What local opportunities are there for a beginning tournament angler? What advice would you give to a beginner who is interested in trying competitive angling?

Troy Morris- *I always get excited when I hear someone is thinking about entering a tournament for their first time. Competitive angling is a great sport for anyone, it gets in your blood stream and never leaves. My first suggestion would be to find a partner. Choose an event on a body of water you are used to fishing, sign up and go have fun. There is not a better time to learn something than when competing against other anglers that have done better than you have at the end of the day. Observe them, learn from what they did and pay attention to details. Secondly, I would recommend signing up for the NWT (National Walleye Trail) Professional/Co-angler event as a co-angler and go fishing for 2 days with the pro's. This is a learning experience that you will never forget. If anyone would be interested in entering tournaments please do not hesitate to contact me anytime. I would be happy to guide you in the right direction.*

Corey Heiser- *There are a ton of good tournaments close by to get your feet wet. The FM Walleye tournaments, Minnesota Tournament Trail, Dakota Anglers Event on the Jamestown Reservoir, the Chamber or Casino Tourneys on Devils Lake.*

The first thing is to SIGN UP! Then after that, use the FM Walleye club members as a resource. There are MANY accomplished tournament anglers in our club...we're talking about Tom Backer, Dave Randash, Bryan Bjorkman, Don Denning, Troy Morris...the list goes on and on. These guys provide a wealth of knowledge and are willing to help if you seek them out. One other thing, sign up for tournaments on bodies of water you're not familiar with, this will push your comfort level and challenge you to become a better angler. I've met some of my best friends fishing tournaments and have learned more than I could have ever imagined.

FM Walleyes Introduces the CHAMPIONS CHALLENGE MYSTERY LAKE TOURNAMENT

FM Walleyes Unlimited Inc has announced a new tournament event with a fresh approach for Tournament anglers. The Champions Challenge Tournament will incorporate a secret lake format, with payouts not affected by participation at less than full fields, and include the Catch, Photo, Release (CRR) method to record fish caught.

The FM Walleyes Champions Challenge Tournament will be held between June 15 and August 31 in 2014. The CRR approach allows FM Walleyes to hold a mid-summer tournament with no fish kill as fish are released within seconds of being caught into the same area caught. The tournament date will be set after other top-tier tournament circuits announce their 2014 schedule to eliminate scheduling conflicts for anglers fishing the MWC, AIM, and NWT circuits. The tournament will be on a lake within 60 miles of Detroit Lakes, Minnesota.

Tournament Director Barry Chouinard, NPAA 996, explains the tournament is taking a fresh approach to walleye tournament competition by placing an emphasis on contestants making winning decisions while on the water with the clock ticking during this one day event. The tournament will be a team event with 2 anglers per team and a \$500 entry fee that will be paid back 90% to the top 10% of the field evenly. Defining payouts this way allows anglers to avoid the diminishing payouts that have resulted due to the reduced walleye tournament participation that is occurring nationwide. Each team in the top 10% will earn a \$4,500 check while at the same time incurring fewer expenses due to prefishing activity expenses. The payout amount will remain the same regardless of the number of teams entered. Predictable payouts are accomplished by eliminating a heavily loaded first place payout, and payouts deeper into the field. With the reduced expense of participating, every team earning a check is likely to exceed their team's expenses to participate. To encourage teams to stay for the post tournament awards, one team not in the top 10% will be selected for a \$1,000 check if they are present to claim the award during the awards ceremony.

The Champions Challenge Tournament will be limited to teams that qualify through earning a check in one of the 3 FM Walleyes Classic Cup Tournaments during 2013. Those tournament are The Pelican Spring Classic – May 31-June 1, 2013; Scott's Bait Ottertail Tournament – June 14-15, 2013; and the Big Cormorant Fall Classic – September 21-22, 2013. New for the Classic Cup Tournament season is the addition of Scott's Bait Tournament. This tournament will not be included in the season points calculation where the best 2 finishes in these 3 tournaments will count toward the final standings. The season points competition includes attractive awards and incentive payouts by the Classic Cup Tournament sponsors. Lund Boats will again provide anglers fishing out of a Lund boat in all Classic Cup Tournaments a \$2,500 bonus if they win the season points Championship. Mike Kerzman and Dave Longtine each won the Lund \$2,500 season points bonus in each of the last two years, in addition to winning the Lund Boat and Shoreland'r trailer combo awarded to the angler winning the Classic Cup Season Points Championship. DOC SAMSON *aka Doctor Sonar* JOINS THE BERKLEY TEAM

One of the winningest walleye tournament professional anglers, Bruce Samson, recently became a promotional partner with the popular Pure Fishing family of fishing tackle. He is known throughout walleye circles as “Doc” because he is a medical doctor turned walleye fishing guru. He is recognized as the master of everything electronics, and his live schools and DVD training courses have been attended by thousands.

On the water, Doc has always fished to win, a strategy that has paid handsomely. He won the 1986 MWC World Walleye Championship and a Lake Winnebago MWC tournament the following year. Most recently, he captured the AIM Lake Erie event; with PWT victories in 1999 and 2002 on Devils Lake, on Mille Lacs in 2001 and Ottetail Lake in 2006. He also claimed \$300,000 in the RCL (forerunner of the FLW) Championship in 2002. His total walleye winnings are approaching \$1,000,000.

Doc said, “I am the live bait and large walleye expert, but have learned years ago that bigger fish prefer soft artificials like Gulp! over live bait and this is just one tactic that I will share. He will represent Gulp!, PowerBait, Trilene, Fenwick, Pflueger, Abu Garcia and Berkley while working closely with Pure Fishing field marketing manager for the Midwest, Cody Roswick, who said, “Doc brings a lot to the table with his walleye universities, sonar and GPS education, strong retail experience and his skills at teaching the public to catch fish.”

Through every means possible, Doc has been educating anglers about boat electronics, including classes, seminars, Doctor Sonar Facebook, articles in major publications, TV shows, internet forums, in stores and on the water. “It is impossible to teach only electronics, because after teaching people how to find fish, they want to know how to catch them,” Doc said.

For 2013, Doc has three on-water Walleye Schools set. Schedules and sign-up is on his website. He will be one of the “professors” at the Scheel’s Universities to demonstrate and teach store employees his Gulp! and PowerBait tactics that have won tournaments. He added, “I’m thinking there may be some electronics questions asked, also.”
