We would appreciate each club sending the candidates a list of the questions which they need to answer prior to the forums. If you are not able to hold a forum in your area, have the candidates fill out the questionnaire and send them back to your club. If the candidate does not respond, it will indicate to the sportsmen of ND that they do not hold the interests of the fish and wildlife as a priority. **We have the power at the poll in November** to vote in the candidates that support the interests of natural resources of North Dakota. If the

clubs would e-mail or send a copy of responses to <u>sportfishing@bis.midco.net</u> or mail them to 311 Laredo Drive, Bismarck, ND 58504, we will post the results to our web site (www.ndsportfishingcongress.org). So please check our web often!!!

Boy, aren't we lucky to be living in this great state? It seems like every time we could catch as many fish as we wanted. With a large part of the state in drought conditions, some lakes could be gone in the next few vears: we will have less lakes to fish in the coming years. There is more pressure on our resource from visiting fishermen, more tournaments held on just a few lakes and lakes' habitats declining as they get older. Our lakes can only produce so much fish to be shared with all the users. The fishing guide contains the daily bag limits and possession limits for fish; it is very important that fishermen read this information. When people overlimit or double dip, that is someone taking more than their fair share, it hurts the other honest anglers and the resource. If we, you and I, report those dishonest fishermen, the fishing resource will benefit. If we, people who care about the fishing, don't help the enforcement by reporting violations when we see them and be willing to go to court if needed, we are not only hurting the resource, but we are just as guilty as those breaking the law.

In closing, get out and enjoy our great outdoors. Remember to take a kid fishing; the kids are our future!!!

NORTH DAKOTA GAME AND FISH DEPARTMENT PERSPECTIVES by Greg Power

With a rather slow winter of fishing this past season, many questioned what kind of fishing would welcome anglers this summer. Thankfully for most, North Dakota offered some wonderful fishing and catching (!) opportunities. The traditional large walleye fisheries were outstanding. The spring walleye fishing on the Missouri River was probably the best we've experienced in nearly a decade (nearly 100,000 walleye were harvested through the end of June!). Gizzard shad (a warmwater forage species) is directly responsible for a significant increase in the condition of Missouri River walleye. Despite near record low lake levels, Lake Sakakawea has experienced one of its best summers ever in terms of both walleye catch and harvest. Through the end of July, more than 700,000 walleye have been caught and approximately 450,000 walleye harvested by anglers. Larger walleye have been more difficult to catch as growth rates and condition of walleye have declined due to the low lake level and the corresponding reduction in the rainbow smelt population. And lastly Devils Lake experienced yet another outstanding summer of walleye and even pike fishing. Although we don't have numbers, we expect the harvest in 2006 to be similar to the past few years.

Although these three fisheries receive a lot of angler attention in North Dakota, some excellent fishing was found in many smaller water bodies this summer. Jamestown Reservoir, Fish Creek, Antelope Lake, Stump Lake and Northgate Dam are but a few water bodies that provided a lot of excitement for anglers.

We did experience more than normal summer kills at lakes scattered across the state. That should come as no surprise given the hot/dry summer most of North Dakota just experienced perhaps 'winter' will bring some relief. However, even though a strong winter snowpack coupled with good runoff next spring would bring some of that 'relief', a long snowy winter would likely lead to more winterkill lakes.

In the end, it really doesn't matter what we would like to see as Mother Nature will once again dictate where we'll sit come next spring If you've lived in North Dakota most or all of your lives and like to fish, you've come to learn the virtue of humility!!! What Mother Nature gives, she can take away in short order. Nonetheless, both the North Dakota Game and Fish Department and the angling public need to continue to address a multitude of challenges so we can attempt to protect and/or improve roughly 300 fishing water bodies. Some of the more important challenges I foresee in the next few years include the following:

✓ <u>Water Quantity</u> – maintaining sufficient water in our fishing lakes when there are competitive uses for that water will likely become an increasing challenge. Demand for water, especially in the western half of North Dakota will follow trends observed in other western states and unfortunately, the Depart-

ment doesn't have a good mechanism and/or legal authority to protect many of our fisheries. Protecting the public's water for fishing needs to be a high priority.

- ✓ <u>Water Quality</u> our five-year-old Save Our Lakes (SOL) program has helped in a number of lakes across the state. The SOL program continues to slowly grow (especially finding other financial partners) in an attempt to meet these challenges. However, the task is daunting as all land use practices will continue to affect the water entering our lakes.
- ✓ <u>Clean Bait</u> for the past fifteen years, a great effort has been put forth by the Department in an effort to educate both the angler and the bait vendor concerning the potential impacts of 'dirty' bait. Although this effort has paid great dividends, it too will be an endless challenge due to both angler and vendor complacency and turnover.
- ✓ <u>ANS</u> laws were enacted in the past legislative session and the governor has approved North Dakota's ANS plan/program. In the days and months to come, rules and regulations will be developed to lessen the chances of introduction of ANS into State waters. Again, education will remain the foundation of ANS.
- ✓ Public access to public resources for many and varied reasons, 'true' public access, especially shore fishing opportunities, are slowly dwindling. Both internal mandates and external pressures have caused numerous government agencies to tightly regulate shoreline access. Since most current anglers received their first exposure to 'fishing' via some type of shore experience, a strong need continues to exist to bring some common sense to this issue.
- ✓ Maintaining the state-federal hatchery partnership although there are no immediate threats, maintaining the fantastic working relationship between the Garrison and Valley City National Fish Hatcheries and the Department will likely become a challenge as federal budgets dwindle and priorities shift.

These challenges and priorities outlined above are but a few of many. It will need to be a group effort by all to provide the needed protection in order to ensure the long-term well-being of the wonderful fishing opportunities that exist in North Dakota.

As always, find some time and prioritize a trip to your favorite 'fishing' hole. Ample opportunities await you – get out there and experience it ... and take a family member and/or a friend. Happy angling!!!



RED RIVER AREA SPORTSMEN'S CLUB UPDATE

The Red River Area Sportsmen's Club of Richland County, ND and Wilkin County, MN enjoyed a busy fishing year.



The Youth Ice-Fishing Derby at Heitkamp Pond north of Wahpeton was held in early February, later than previous years because of thin ice conditions during much of January. Over 150 children

participated and there were good catch-and-release numbers, including crappies, walleyes and a whopper smallmouth bass. Credit for this successful event goes to Heitkamp Construction, who provides free food, beverages, bait and door prizes for every contestant.

The Youth Fishing Derby held for over 20 years on the first Saturday in May attracted over 115 girls and boys. It is amazing the number of different fish that come out of the Red River – this year 11 species (carp, catfish, drum, goldeye, northern pike, rock bass, redhorse sucker, smallmouth bass, walleyes, white bass and white suckers).

There are additional species that have been caught over the years, too - never know what you're going to pull up. We see lots of mothers and fathers fishing with their children during this tournament and it's great to see families enjoying quality time together.

A fishing tournament was sponsored during the ND Firefighters Conference. The Great Bend and Fairmount Fire Departments co-sponsored the event with our club. We often work together with other organizations to form effective partnerships. The firefighters enjoyed shorefishing and delicious shore lunches.

A Catfish Tournament was held during Carousel Days, a local event organized by the Chahinkapa Zoo Association and Chamber of Commerce. Catfish are a little smaller towards the headwaters of the Red River but normally there are fish caught approaching double digit pounds. There is both a cash division and youth division. Our club often participates with civicminded events.

The club annually sponsors a Carp & Sucker Derby, where only these rubber-lipped fish are eligible for prizes. We encourage area fishermen to enjoy the great fight put up by carp and the different ways to catch them, including fly fishing and with bows and arrows.

The Sportsmen's Club also sponsors prizes for other fishing derbies in the area, including the Silver Lake Ice-Fishing Derby, Long Lake (MN) Youth Fishing Derby, Lake Elsie Ice-Fishing Derby and Lake Tewaukon Spring Fishing Derby, to name some. A kid is a kid is a kid, and multi-club events only make the fishing experience that much more successful.

Fishing on the Red River is a destination for out-ofstate fishermen from Missouri, Iowa, Kansas and Nebraska, to name a few. Tourism is a large industry, and we're pleased that our non-resident guests enjoy the boat ramp, fishing piers and fish cleaning stations supported by the Red River Area Sportsmen's Club. This year, we sponsored a fishing pier in south Wahpeton along the Bois de Sioux River. One of the benefits of flood protection projects up-and-down the Red River Valley has been the resulting greenway and considerable more public access to a terrific natural resource – the Red River.

Club members are working with the Minnesota Department of Natural Resources to develop public access on the Ottertail River east of Breckenridge. There is some fantastic fishing on the Ottertail, and some say the smallmouth bass fishing is some of the best they've ever experienced.

Although Mooreton Lake has experienced its up-anddowns, the Red River Area Sportsmen's Club remains active with its fishing facilities, including fishing piers, boat ramp, water testing, shoreline fishing development, etc.

Five boys were given scholarships to attend the ND Wildlife Federation Camp on Lake Sakakawea. They had a super time and all indicated they'd like to attend again. The rod-and-reel loaner program in partnership with the ND Game & Fish Department has also proven to be very successful. Youth groups like 4H, Boy & Girl Scouts and after-school programs are frequent users. The equipment is also offered during the youth fishing derbies for those without rods & reels and tackle. The reels are switched from long rods during summer months to short rods for ice-fishing in the winter.

Efforts to promote the Red River as a readily accessible local fishing resource appear to be working. It gives club members a good feeling when they see a youngster on a bicycle with a rod and reel over a shoulder and a landing net and tackle box balanced on the handle bars en route to a favorite river fishing hotspot. Maybe not the safest way to ride a bike but spurs memories of when we were river rats, too.

The Hunters Smoker is scheduled on Friday, October 27th from 7-11 PM at the Eagles Club in Wahpeton. This is the club's major fund-raiser and proceeds help benefit the various fishing opportunities provided during the year.

The Youth Ice-Fishing Derby is scheduled at Heitkamp Pond on Saturday, January 6th and next summer's events are scheduled again, too. We're committed to continue offering the great sport of fishing to youths in southeastern North Dakota and west-central Minnesota.

NOTHING NEW IS GOOD NEWS

The North Dakota Game and Fish Department searched in numerous lakes and reservoirs this summer for aquatic nuisance species (ANS) infestations. ANS are those invasive nuisance species which ruin fishing, boating, and hurt hunting opportunities. A special Fisheries crew did multiple samples at multiple sites on over 50 waters and the Missouri River system and Devils Lake to determine if ANS was present. In addition, regional Fisheries' field crews looked for ANS in another 25 lakes. The outcome was – NO new ANS infestations were found.

Known ANS infestations were also monitored. Curlyleaf pondweed is well established in the lower reaches of the Missouri River and McDowell Reservoir. There are spotty patches of Eurasian watermilfoil and curlyleaf pondweed in the Sheyenne River near Valley City. To eliminate an infestation, drastic steps are needed to prevent the infestation from spreading to other waters. Dead Colt Creek Reservoir's water level was dropped 10 feet last winter to freeze out Eurasian watermilfoil. An unheard of action for a prairie state which normally short of water, but it is still too early to tell if this was a totally successful in eliminating this ANS infestation.

This summer's work shows that many of North Dakota's waters are not ANS infested, the need to protect them for problems still exist. If we don't do the right thing now, we will have – less fish to catch, not as many ducks, and weed cluttering the surface of our waters. The problem can show up in our wallets as power companies and municipal water plants have to charge more to cover additional expenses of O/M from ANS infestations.

Prevention is cheaper and simpler than attempting to contain an infestation. The steps in prevention take only a couple of minutes to do when leaving a lake and a couple more when you get home. A quick review of prevention protocols is:

- ✓ Remove all vegetation on the boat, the motor, trailer and other equipment before leaving the boat ramp.
- ✓ Drain all water from the livewells, bilge, or other confined areas at the boat ramp.
- ✓ Disinfect and powerwash the boat/trailer at a carwash before launching the boat again.
- ✔ Don't dump bait overboard.
- ✓ Clean off duck decoys, anchor lines, and duckboats.

The little time it takes to prevent ANS can mean a lifetime of enjoyment of fishing, duck hunting, boating, and cheaper household bills.

GARRISON DAM NATIONAL FISH HATCHERIES

This year's hatchery report is shaping up to look a lot like last year's. Garrison Dam National Fish Hatchery set



another fish production record - last year we produced a record number of walleye at 10 million. This year we broke the walleye weight record -6,860pounds. That's 8.7 million one and a half inch long fish. As long as I'm throwing out numbers, over the past ten years, this hatchery has produced over 72 million walleye. So for all you fishermen complaining about those 14 inch fish taking your crawlers, you know where those fish came from! If you are a trout angler you might have also noticed that the rainbows stocked out this year were a little larger than in the past — broke that record as well. And if you remember this past Spring I was telling you the ND Game and Fish Department had put in a huge request for perch stockings in Devils Lake – we exceeded that request with over a million fish stocked into both Devils Lake and Lake Darling. Time to clean out the ice houses and pack the wheel bearings!

If you have the opportunity, write a note of thanks to Senator Dorgan for his support of the hatchery. Over the past four years the Senator has provided a million dollars to the hatchery to renovate its leaky walleye ponds with plastic liners. The result has been an increase of over a million walleye, pike and perch annually. This year he has included an additional \$300,000 to our annual appropriations for more liners. If we can get the amendment through the House later this fall it may show up as another walleye in the live well in a couple years. Seriously though, without this funding our ability to meet the stocking needs across the state would be limited.

Enjoy the fall weather and fishing opportunities and stop by the hatchery if you are up fishing the big lake.

BARNES COUNTY WILDLIFE FEDERATION

January 7th - ice fishing derby at Sibley, Lake Ashtabula.

April is the tree reef project. Each year at this time we use discarded Christmas trees to form reefs at different parts of the lake. This is to try to enhance perch spawning areas.

June sees the annual "Take a Kid Fishing" day with kids not only fishing, but taking part in several mini-seminars and a casting contest. This is held in conjunction with other organizations that provide rides, prizes, meals and help with the seminars.

June 10th and 11th was the date for the summer walleye tournament. This involved 80 teams this year with prizes for walleye, northern and pounds of bullheads. The Lake Users Association helps with the weighin.

The club worked with the Corps of Engineers to provide another handicap accessible fishing pier. This year, it's at Eggert's Landing. Also this year, with the cooperation of the Fingal Wildlife Club, the Kathryn Dam site was enhanced with a walk bridge, rest room, steps and parking lot. The Kathryn Dam is located on the Sheyenne River along the National Scenic Byway system, which also has an interpretive panel and historic site in this area.

The club also sponsors interested youth to summer wildlife and fishing camps.

BCWF has a Junior Naturalist Club that meets every month of the school year to learn more about the outdoors and includes several fishing seminars.
